# Reminder: Dual claiming for zostavax® and fluad® quad when given at the same visit is now automated

Up to now, when another funded vaccine is given at the same visit, only one immunisation benefit can be claimed. We are pleased to advise that there is now an automated dual claiming process to allow immunisation benefit claims to be accepted when administering **Zostavax** and **influenza** vaccines at the same visit and is fully automated within all PMS systems. # 2021 Influenza Immunisation Campaign Update

The Ministry of Health recommends that children 0-4 years, who have been hospitalised with a respiratory condition or have a chronic medical condition are immunised against influenza. It is important to encourage immunisation for this group of patients as it can prevent further hospitalisations. Now is the time to commence the recall process to invite these children for their influenza vaccination now – in readiness for mid-May.

### Fluad Quad vaccine

A reminder that Fluad Quad MUST NOT be given to a person under 65 years as it is approved by Medsafe only for people aged 65+ years. Please refer to the Medsafe website https://www.medsafe.govt.nz/safety/Alerts/FluadQuad.asp.

The reason it is not approved for use in New Zealand in people aged under 65 years is because Medsafe has not evaluated the safety data for this group

### Afluria Quad, Influvac Tetra and Afluria Quad Junior

Vaccine supplier Seqirus has confirmed that the vaccines for people aged under 65 are on track to be available for the programme start date of 17 May for this age group – however, if you have stock and the claiming option is on your PMS, you can commence vaccinating this age group.

### Vaccine returns

Vaccine supplier Seqirus has agreed to increase the return allowances for the 2021 season and will accept the following returns for a refund at the end of the 2021 season:

- Fluad Quad (for 65 years and over) one box of 10 doses
- Afluria Quad (for 5 -64 years) one box of 10 doses
- Influvac Tetra (for 3- and 4-year-olds) 5 doses
- Afluria Quad Junior (for 3-35 months) 5 doses.

# Minimum order quantities

Seqirus recognises the complexity of the 2021 season with multiple vaccines and has agreed to reduce the minimum order quantity for Fluad Quad from 60 doses to 30 doses until other vaccines are dispatched. This is to allow providers to complete all their vaccinations of patients 65+ years as quickly as possible without incurring charges for small deliveries.

Ordering of Afluria Quad, Influvac Tetra® and Afluria® Quad Junior opened on 27<sup>th</sup> April. The stock will start being dispatched from 10<sup>th</sup> May, and the minimum order quantity will revert to 60 doses at that time.

### **Patient Information and Resources**

Flu vaccination is now available **FREE** for anyone 65 or older.

Flu vaccine is also **FREE** for pregnant women (any trimester), people with certain chronic conditions, and young children aged 4 years or under with a history of severe respiratory illness (or are hospitalised for respiratory illness).

For those who are under 65, vaccination will be available from 17 May 2021 (charges may apply).

Flu and COVID-19 vaccination:

- You can have your annual flu shot and your COVID-19 vaccination, but not at the same time.
- o Get your COVID-19 vaccination first if you have an appointment booked for it.
- o If you do not have an appointment booked for a COVID-19 vaccination, get your flu shot first.
- Leave a gap of two weeks between the COVID-19 vaccine and flu vaccine. Please note that whilst a twoweek gap between flu and COVID vaccines is recommended there are no clinical safety concerns should the gap between vaccines be less than two weeks.

### COVID-19 vaccination information available on HealthPathways

<u>Auckland COVID-19 Vaccination Information</u> contains up to date information and resources on COVID-19 vaccination. This includes: The Immunisation Advisory Centre (IMAC) vaccinator training link for general practitioners, the updated advice from IMAC for vaccination in pregnancy and breast-feeding, a link to the Ministry of Health website for those applying for an early vaccine for travel, and an interactive tool to indicate when someone will be vaccinated.

# Protecting against measles during the COVID-19 roll-out

As the COVID-19 vaccine roll-out builds, it provides opportunities to check in with people that they are up to date with other vaccines too. As we have experienced, it can be a challenge to vaccinate 15-30-year-olds, and you are encouraged to make the most of any touchpoints you have with this cohort and check if they have been immunised against measles vaccinate them at that encounter (if appropriate).

While our border settings provide some protection from measles, a number of countries are experiencing measles outbreaks. This makes our large group of unimmunised teenagers and young adults vulnerable as travel restrictions ease.

# Updated advice on gap between MMR and COVID-19 vaccines

Please continue to allow a four-week gap when giving the MMR vaccine **before** the COVID-19 vaccine where possible.

However, the gap only needs to be two weeks when giving the MMR vaccine **after** the second dose of the COVID-19 vaccine.

Continue to allow a two-week gap between the COVID-19 vaccine and influenza vaccine, or any other non-live vaccine such as Tdap, where possible, regardless of the order they're given.

# Why we leave a gap between COVID-19 and MMR/flu vaccines

Having a gap between the different types of vaccinations makes it easier to judge which vaccine may be responsible for any side effects. Note that there are no clinical safety concerns should the gap between vaccines be less than the recommendations above. Do not delay vaccination if such a gap is not possible. It is more important not to delay vaccines than to enforce the gap where it isn't feasible.

The MMR and influenza vaccines can be given at the same time.
